2. The Promotion will be advertised in-store at OTR stores within SA, NSW, VIC, QLD, WA, NT and TAS.

Entry

4. The Promotion will be conducted during the Promotion Period. To enter, entrants must comply with the Entry Instructions during the Promotion Period. Any entry must be made personally. No entry made by a third party on behalf of an entrant will be valid.

29. Furthermore, the Promoter, its affiliates, employees, agents and distributors will not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible entries; (ii) telephone, electronic, hardware, or software program, network, Internet, or computer malfunctions, failures, delays or difficulties; (iii) errors in transmission; (iv) reward notification deliveries attempted but not received; (v) any loss suffered by anyone who enters or attempts to enter and/or participate in the Promotion, whether the entry is lost, not submitted, wrongly processed or does not win.
30. In case the reward is a good or service offered by a third party, the responsible or liable company in case of damages is the entity providing the service or good.
31.
