Eligible entrants:	Entry is only open to Australian (excluding ACT) residents aged 18 years or over.
How to Enter:	To enter the Promotion, the entrant must complete the following steps during the Promotional Period: a) download the OTR App from the App Store or Google Play (using their compatible mobile device) and successfully complete the registration process to use the OTR App. If the entrant already has the OTR App, they must log into their account; b) purchase any two (2) x 600mL Coca-Cola varieties in one (1) transaction ("Qualifying Spend") from any OTR store displaying advertising for this Promotion (excluding online) ("Participating Stores"); and c) scan their OTR App (by providing their barcode found on the OTR App to the staff) at the checkout. Entrants must continue to have an OTR account at the time of the draw to be eligible for a prize. Entries will be recorded upon completion of the above steps.

collect personal information about entrants to run this Promotion and may disclose entrants' personal information to their related entities and to third parties including their contractors and agents, prize suppliers and service providers to assist in conducting this Promotion. The Collectors may also disclose entrants' personal information to the State and Territory lottery departments as required under the relevant lottery legislation. By entering, entrants consent to receive email or SMS messages from the Collectors without any functional unsubscribe facility if they relate primarily to the conduct of this Promotion. Any guarantee or warranty given is in addition to any relevant statutory guarantees and warranties and nothing in these Conditions of Entry restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the Competition and Consumer Act 2010 (Cth).

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may, in its sole discretion, cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.
19. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). If a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. The use of any automated entry software or any other mechanical or electronic means that allows an individual to automatically enter repeatedly is prohibited and may render all entries submitted by that individual invalid.
20. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Conditions of Entry. For the sake of clarity, this clause shall not apply where the Promoter and/or On The Run has contributed to or caused such loss, expense, damage, personal injury or death and shall not apply to any liability which cannot be excluded by law (in each case the Promoter's and On The Run's liability is limited to the minimum allowable by law).
