

**Celsius Live Fit Pack Promotion On the Run  
Terms and Conditions Australia**

<b>Promoter</b>	Suntory Beverage & Food Australia Pty Ltd (ABN 73 060 091 536), Tower 1, Level 18, 201 Sussex St, Sydney, NSW, 2000																														
<b>Eligible Entrants</b>	The promotion is only open to Australian residents (excluding ACT) aged 18 years and over.
